## 60-DAY SATISFACTION GUARANTEE POLICY

If you are not satisfied with the performance of this MORSE power tool during the first SIXTY DAYS from the date of purchase, you may return the product for a full refund or exchange. Simply return the product to the point of purchase along with a copy of the purchase receipt or other proof of purchase. Morse power tool accessories are covered under a separate warranty.

This 60-DAY SATISFACTION GUARANTEE does NOT cover (i) products that have been altered, (ii) damage caused by repairs made or attempted by someone other than an authorized MORSE representative, accidents, abuse, misuse, or improper maintenance, or (iii) normal wear and tear.

## ONE YEAR LIMITED WARRANTY

This MORSE power tool is warranted to be free of defects in workmanship or materials for ONE YEAR from the date of purchase. MORSE will repair (or replace, at MORSE'S discretion) without charge any product that our inspection shows to be defective in materials or workmanship.

To obtain warranty service during the ONE YEAR period of this warranty, simply call Morse for an RGA number before returning the original product, together with all its parts and accessories, along with a copy of the purchase receipt or other proof of purchase, freight prepaid and insured, to MORSE at the address provided below. Any repaired or replaced product will be covered by this limited warranty for the duration of the ONE YEAR LIMITED WARRANTY period on the original product.

This ONE YEAR LIMITED WARRANTY does NOT cover (i) products that have been altered, (ii) damage caused by repairs made or attempted by someone other than an authorized MORSE representative, accidents, abuse, misuse, or improper maintenance, or (iii) normal wear and tear.
